- **5.-** We will reduce the quantity and/or hazardousness of waste, spills and emissions generated as a consequence of the company's activity. We will gradually introduce those techniques and scientific advances that, being economically viable, allow us to guarantee an adequate protection of health and the natural environment.
- **6.-** We will establish energy criteria in the design and seek continuous improvement of energy performance and our energy management system.
- **7.-** We will evaluate the risks and apply the necessary corrective measures to avoid them, reducing the possibility of accidents occurring and monitoring the health of the workers.
- **8.-** We will provide the necessary training, awareness and motivation to the company's staff to promote a culture of quality, safety and respect for the environment and energy efficiency during the performance of their responsibilities and functions.
- **9.-** We will disseminate the commitment acquired by CHILCHES MATERIALS S.A. among our employees, customers, suppliers and all those who act on behalf of the company, encouraging them to know and act in accordance with the principles established in the framework of this policy.
- **10.-** We will promote the acquisition of energy efficient products and services that have an impact on energy performance.
